ENROLLMENT CONTRACT FOR THE 2009 – 2010 SCHOOL YEAR

All copies of this Contract must be signed by the parents or guardians financially responsible for the student and returned to the School. A non-refundable deposit of \$500.00, which will be credited to the student's account, must accompany this Contract. Gavilan Hills Academy will not reserve a place for the student until the Enrollment Contract and deposit is received.

Upon acceptance of the student for enrollment, a copy of this Contract will be countersigned by the School and returned to the parents.

It is understood that confirmation of this Contract signifies the obligation of the undersigned to remit the charge for tuition and all related fees for the school year. Tuition may be paid in one installment (due upon enrollment); in two installments due: two consecutive months after enrollment; in four installments due: four consecutive months after enrollment. Extended payment arrangements may be made for up to ten months beginning September 1, 2009 and continuing through June 1, 2010.

It is understood that the student will not be admitted to School unless the deposit and all payments are current. It is understood that should tuition payments become 45 days in arrears the student will not be allowed to continue attending Gavilan Hills Academy until full financial obligations for the entire year have been paid.

The School must and does reserve the right to dismiss or require the withdrawal of any student whose record of scholarship or conduct is not in keeping with the School's standards. It is further agreed that confirmation of the student's enrollment confirms a place for the entire school year and that no reduction or rebate of tuition will be made in the event of early withdrawal and/or dismissal.

Confirmation of enrollment will be made by the School upon receipt of this Contract and the appropriate deposit except when the student's record to date indicates the advisability of withholding final action on the Contract until completion of the current school year. In the event that enrollment confirmation is withheld and the student is not accepted for enrollment at the School's initiation, the deposit will be refunded in full.

In the event suit is initiated to collect the above account or any portion thereof, the undersigned agrees to pay such additional sums as the court may judge reasonable for attorney's fees and costs in said suit.
